HC condemns TVK leaders for 'abandoning' victims

■ '(Vijay) fled from Karur scene - Vanished', says judge

Observing that the stampede at the Karur election rally of the Tamilaga Vetri Kazhagam (TVK) on Saturday was a man-made disaster, the Madras High Court expressed anguish over police inaction against the party president Vijay pointing out that he had fled the scene and ordered the constitution of a Special Investigation Team (SIT) headed by Inspector General of Police Asra Garg to probe in the tragedy.

It was agonising for him as a judge to see the death of 41 people in the stampede and asked the police what they had done so far but for arresting just two people.

The judge also asked why the police had not issued any notice to the TVK since an unprovoked mob indulged in all kinds of activities and what prevented the party from taking precautionary measures at the rally in Karur.

When the entire world had witnessed the unfortunate incident and everyone, right from the President of India and Prime Minister had condemned the loss of lives, the police action did not appear to be adequate, Justice Senthilkumar said, raising a plethora of questions against the police.

Chennai: Lambasting actor-politician Vijay and his followers, Madras high court ordered a probe by a Special Investigation Team (SIT) on Friday.

Citing two accidents involving Vijay's campaign vehicle, which did not stop even after dashing against the bikes of his accompanying cadres, the court also ordered registration of a hit-and-run case against the leader.

Madras High Court sets up SIT to probe Karur stampede

The Madras High Court on Friday ordered the constitution of a Special Investigation Team (SIT), headed by Inspector General of Police Asra Garg, to probe the stampede that claimed 41 lives during TVK president and actor Vijay's political campaign in Karur on September 27.

Expressing 'anguish' over the death of 41 people during the September 27 stampede at Karur, the Madras High Court on Friday ordered a special investigation team (SIT) to probe the incident. Justice Senthilkumar also recorded that the court "highly condemns" the act of the TVK leaders in having "abandoned" the innocent people who had thronged the venue at Velusampuram just to have a glimpse of Mr. Vijay but ended up losing their lives. He said the party ought to have come to their rescue.

Meanwhile, the Madurai Bench of the court refused to order a CBI probe and dismissed the anticipatory bail pleas of TVK general secretary N. Anand, alias 'Bossy' Anand, and joint general secretary C.T.R. Nirmal Kumar.
